Beginning as a Senior Naval Officer in the Republic of Singapore Navy, I developed a disciplined foundation in engineering, operations, and leadership. My subsequent roles in Hyflux, where I led operations in both domestic and international water treatment projects, further exposed me to the nexus of infrastructure, public utilities, and sustainable resource management. At ClimateCrafters, we combine technical capability in renewable energy systems (solar PV, battery energy storage, microgrids) with structured financial advisory, supporting capital providers in deploying billions of dollars into viable, high-impact projects across the region.

My deep domain knowledge in energy markets and operational project delivery is complemented by strategic engagements with policymakers and investors. Notably, I have served as a Market Advisory Board Member for Singapore's Electricity Market and advised regional energy platforms such as Energy Risk Asia and Enlit Asia. These roles reinforce my belief that systemic energy transformation must be guided by practitioners who understand both the technical frontlines and the strategic levers of industry-wide change.

The decision to pursue a Doctorate in Business Administration (DBA) with the International Business School of Scandinavia (IBSS) is a natural extension of this
